The above identified application was made or was authorized to be made by the person executing this oath/declaration. I believe that I am the original inventors or an original joint inventor of a claimed invention in the application. I have reviewed and understand the contents of the above referenced application and I am aware of the duty of disclosure under Rule 1.56. I hereby acknowledge that any willful false statements

made in this declaration are punishable under 18 U.S.C. §1001 by fine or imprisonment of not more than five (5) years, or both.”

I further covenant and agree and bind our heirs, legal representatives and assigns, promptly to communicate to said assignee and its representatives any facts known to us relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the assignee, its representatives, successors or assigns to secure patent or similar protection for said invention in all countries and to vest in the assignee complete title to said invention and Letters Patent, without further compensation, but at the expense of said assignee, its successors, assigns and other legal representatives.
