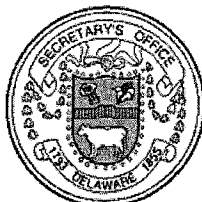

FIFTH: The authorized stock and par value of the non-Delaware corporation is 100 common shares with no par value.


SIXTH: The merger is to become effective on July 1, 2018.
