Such assignment, transfer and/or conveyance by the Secured Party is made WITHOUT ANY REPRESENTATION OR WARRANTY OF TITLE AND WITHOUT RECOURSE. The Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release of Security Interest in Patents; and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement.

The Secured Party shall, at the Grantors' sole cost and expense, take all further actions, and provide to the Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this release. The Secured Party hereby authorizes the Grantors, or the Grantors' designee, to prepare and file any other documents as may be required to terminate or release the Secured Party's interest in any Patent Collateral.
