
1. The current name of the limited liability company is Galera Therapeutics, LLC.

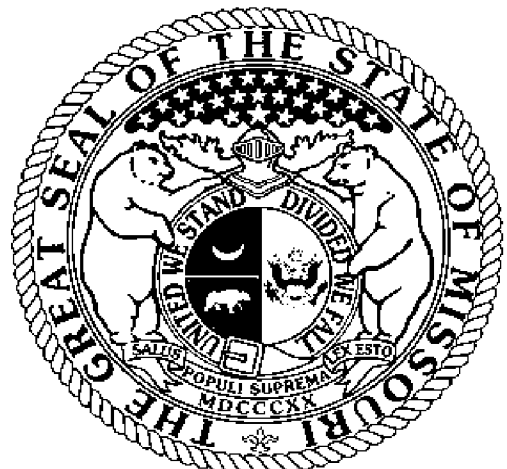
