RELEASE OF PATENT SECURITY INTEREST

This Release of Patent Security Interest (this "Release") made as of August 30, 2018, is granted by Oaktree Fund Administration, LLC (the "Collateral Agent"), as Collateral Agent for the Secured Parties (as defined in the Guarantee and Collateral Agreement referred to below) in favor of the "Grantors" (defined below in Schedule B). WHEREAS, pursuant to the terms and conditions of the Guarantee and Collateral Agreement, the Grantors granted to the Collateral Agent a security interest in all of such Grantors' right, title and interest in and to the Patent Collateral (as defined below), including, without limitation, the patents and any applications relating thereto, set forth on Schedule A hereto;

WHEREAS, under the terms of the Guarantee and Collateral Agreement, the Grantors and the Collateral Agent entered into that certain Patent Security Agreement, dated as of March 22, 2018 (the "Patent Security Agreement");

WHEREAS, the Patent Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on March 22, 2018 at Reel / Frame 045322/0054;

WHEREAS, the Collateral Agent desires to release its security interest in all of the Grantors' right, title and interest in and to the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors and the Collateral Agent hereby agree as follows:

Section 1. Release of Security Interest. The Collateral Agent hereby (i) releases, terminates and forever discharges all of its right, title and interest, and (ii) reassigns to Grantors, any right, title and interest that the Collateral Agent may have, in each case, in or to any and all of the following assets and properties now owned or at any time hereafter acquired by each Grantor or in which each Grantor now has or at any time in the future may acquire any right, title or interest (collectively, the "Patent Collateral"):

(a) all letters patent of the United States or the equivalent thereof in any other country, all registrations and recordings thereof, and all applications for letters patent of the United States or the equivalent thereof in any other country, including registrations, recordings and pending applications in the United States Patent and Trademark Office ("USPTO") (or any successor or any similar offices in any other country), including those listed on <u>Schedule A</u>, and all reissues, continuations, divisions, continuations-in-

part, renewals or extensions thereof, and the inventions disclosed or claimed therein, including the right to make, use and/or sell the inventions disclosed or claimed therein,

- (b) all additions and improvements to the foregoing, renewals and extensions thereof, rights to sue or otherwise recover for infringements, dilution, or other violations of any of the foregoing or any injury to the related goodwill,
- (c) all other rights of any kind accruing thereunder or pertaining thereto throughout the world, and
- (d) to the extent not otherwise included, all Proceeds, Supporting Obligations, products, accessions, rents and profits of any and all of the foregoing.

Section 2. <u>Counterparts</u>. This Release may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an original, but all such counterparts together shall constitute but one and the same instrument.

Section 3. <u>Governing Law</u>. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
