Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation has executed the following Certificate of Merger:

- FIRST:** The name of the surviving corporation is NREC Transitory Corporation, a Delaware corporation, and the name of the corporation being merged into this surviving corporation is Concepts ETI, Inc., a Vermont corporation.
