ASSIGNMENT OF PATENTS

With this Agreement, Assignee may hereby authorize and request the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue patents on applications as described above, to issue all letters patent for any pending Patent applications to Assignee, its successors and assigns, in accordance with the terms of this Agreement.

Section 4. Counterparts. This Agreement may be executed in two (2) or more counterparts (facsimile and electronic transmission included), each of which shall be deemed an original, but all of which together shall constitute one (1) and the same instrument. After facsimile or electronic transmission, the parties agree to execute and exchange documents with original signatures.
