JAM-TOLERANT ELECTRIC LINEAR ACTUATOR

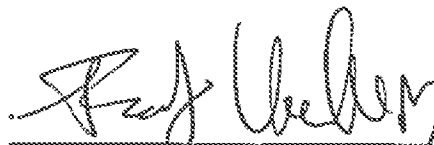
which is set forth in an application in the United States executed on even date herewith:

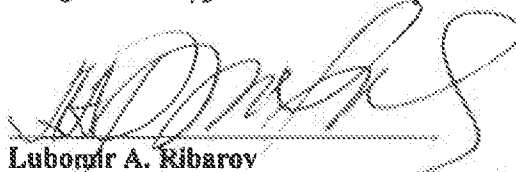
