("Invention") for which a United States provisional patent application was filed on **March 14, 2016** and assigned application serial number **62/308,102** (the "Patent Property"); and



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be bound hereby, Assignor hereby assigns, sells, transfers, and sets over unto said Assignee, effective immediately, his/her entire right, title, and interest in and to said Patent Property and the inventions and improvements therein disclosed or hereinafter developed for the United States and all foreign countries and any Letters Patent which may issue therefrom in the United States and all foreign countries and all divisionals, reissues, continuations, continuations-in-part, requests for continued examinations, renewals, and/or extensions thereof including all priority rights under the International Convention associated therewith for each country in the Union, said Assignee to have and to hold the interests herein assigned to the full ends of the terms of said Letters Patent and any and all divisionals, reissues, continuations, requests for continued examinations, renewals, and/or extensions thereof, respectively, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.

And for the consideration aforesaid, Assignor agrees that he/she will communicate to said Assignee or the representatives thereof any facts known to Assignor respecting said inventions and improvements, and will, upon request, but at Assignee's expense, testify in any legal proceedings, sign all lawful papers, execute all divisional, reissue, continuation, continuation in part, request for continued examination, renewal, and/or extension applications, make all rightful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by said Assignee or by counsel for said Assignee, to assist or enable said Assignee to obtain and enforce full benefits from the rights and interests herein assigned.
