The INVENTOR hereby covenants that he has not executed and will not execute any agreement or assignment in conflict herewith, and further covenants and agrees, each time a request is made, and without delay, to do such acts, and execute such further documents, agreements and assurances, that BOTTLECAP, its successors, assigns,


nominees and legal representatives may, in their absolute discretion, request, in order to protect, perfect, maintain and enforce the Design Rights herein.


