Ltd., and its successors or assigns, to the full end of the term or terms for which said Letters Patent may be granted, as fully and entirely as the same would have been held by me had this assignment not been made.

I hereby authorize and request the Patent and Trademark Office officials in the United States of America and the Patent Office officials of any and all foreign countries to issue any and all of said Letters Patent, when granted to said Schott Glass Technologies (Suzhou) Co. Ltd., as

the assignee of my entire right, title and interest in and to the same, for the sole use and enjoyment of said Schott Glass Technologies (Suzhou) Co. Ltd., its successors and assigns.
