NOW, THEREFORE, in consideration of the payments made to CONTRACTOR by ASSIGNEE under the Subject Agreement, and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNORS, do hereby acknowledge that ASSIGNORS have sold, assigned, transferred and set over, and/or do hereby sell, assign, transfer and set over, unto the ASSIGNEE, its successors, legal representatives and assigns, the entire right, title, and interest throughout the world in, to and under the Improvements, and the Application and all corresponding non-provisional applications, divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all rights of priority under International Conventions and applications for Letters Patent which may hereafter be filed for the Improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for the Improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and ASSIGNORS hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the Improvements to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

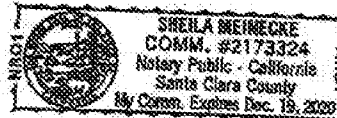

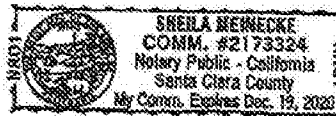

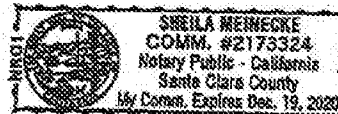
