TERMINATION AND RELEASE OF SECURITY INTEREST PATENTS

This Termination and Release of Security Interest (the "Release") dated as of September 21, 2018, is made by BANK OF AMERICA, N.A., in its capacity as Agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, the "Agent"). Capitalized terms used but not defined herein shall have the meaning assigned to such term in the Loan Agreement (as defined below).

WHEREAS, the Agent serves as Agent for the Lenders pursuant to a Seventh Amended and Restated Loan Agreement dated as of October 1, 2014 (as amended and restated, supplemented or otherwise modified from time to time in accordance with the provisions thereof, the "Loan Agreement"), among Mannington Mills, Inc., Burke Industries (Delaware), LLC and Amico USA, LLC, as Borrowers, the Lenders from time to time party thereto, the Agent, and other parties thereto; and

WHEREAS, under the Loan Agreement and pursuant to a Fifth Amended and Restated Security Agreement dated October 1, 2014, a lien and security interest was created in favor of Agent in certain United States Letters Patent of the Company; and

WHEREAS, Mannington Mills, Inc. desires to assign to Flooring Industries Limited, SARL three of its United States Letters Patent, listed on Schedule A attached hereto (the "Patents"), and has requested a release of the Patents from such lien and security interest; and

WHEREAS, Agent and the Lenders have agreed to grant such a release;

NOW THEREFORE, for good and valuable consideration, without recourse, representation or warranty of any kind, the Agent hereby terminates and releases its lien and security interest in the Patents and authorizes the U.S. Patent and Trademark Office and any other relevant parties, to modify their records to indicate the discharge of said lien and security interest.
