FIRST: On March 12, 2015 by an action taken by unanimous written consent, the Board of Directors of the Corporation duly adopted a resolution approving a proposed amendment of the Certificate of Incorporation (the "Certificate of Incorporation") of the Corporation and declaring said amendment to be advisable. The amendment is as follows:

RESOLVED: That the Certificate of Incorporation of the Company be amended by changing Article FIRST thereof, so that, as amended, said Article shall be and read as follows:


"FIRST: The name of the corporation is "Biogen Hemophilia Inc."
