**RELEASE OF SECURITY INTEREST IN
UNITED STATES PATENTS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES PATENTS (the “Release”) is effective this 31st day of August, 2018, by and between Interface Solutions, Inc. (“Interface”), and Manufacturers and Traders Trust Company (“M&T”).

WHEREAS, Interface entered into an Intellectual Property Collateral Agreement and Notice (the “IP Security Agreement”) with M&T, dated December 21, 2011;

WHEREAS, pursuant to the IP Security Agreement, Interface granted M&T a security interest in all its right, title, and interest to the patents, including the patents and patent applications listed at **Attachment A** (the “Patents”), among other collateral;

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office (the “USPTO”) on November 12, 2014 at Reel 34156, Frame 0061; and

WHEREAS, M&T desires to release its security interest in and to the Patents pledged pursuant to the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, M&T agrees as follows:

Section 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the IP Security Agreement.

Section 2. Release of Security Interest. M&T hereby releases, relinquishes and discharges its security interest in and to the Patents and reassigns any and all interests it may have in such Patents to Interface.

Section 3. Further Assurances. Unless otherwise agreed by the parties, M&T will record this Release with the USPTO. M&T further agrees to execute and deliver any and all further documents and instruments, and do any and all further acts which Interface (or its agents or designees) reasonably request in order to confirm this Release and Interface’s right, title and interest in, to and under the Patents.

Section 4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.
