  - (c) the right to claim priority to the Patents, and any and all applications referenced in subsection (b); and
  - (d) all claims for damages by reason of past infringement of any of the Patent Rights (including provisional rights to reasonable royalties pursuant to 35 U.S.C. §154(d)) and the right to sue for and collect such damages and royalties for Assignee's own use.
2. Authorizes and requests the U.S. Patent and Trademark Office or any other U.S. or non-U.S. agency to issue any and all of the Patent Rights to Assignee.


