

shall extend to the successors, assigns and nominees of BSA.

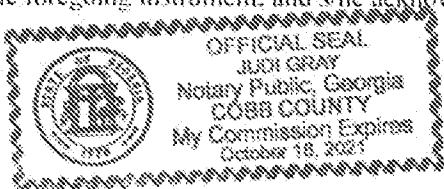


