ASSIGNOR HEREBY REPRESENTS and warrants that said ASSIGNOR has the full right to convey the entire interest of said invention and said applications to the extent not previously assigned pursuant to the Prior Assignment, and have not granted any rights inconsistent with the rights granted herein.
