necessary, desirable or convenient in connection with said applications, patents, or other forms of protection.



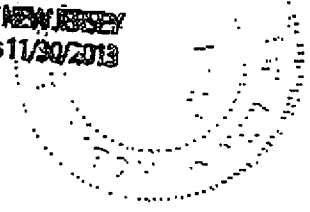


