## CONFIRMATORY ASSIGNMENT

This Agreement is made the 1<sup>st</sup> day of JUNE 2016

### Between:

- (1) **Elena Garcia-Gareta** of 119A, Castlehaven Road, London, NW1 8SJ, United Kingdom (the "Assignor").
- (2) **Restoration of Appearance and Function Trust ("RAFT")**, Company No. 03115825 whose registered office is at The Leopold Muller Building, Mount Vernon Hospital, Northwood, Middlesex, HA6 2RN, United Kingdom (the "Assignee").

### Whereas:

- (A) One or more inventions are described in the patent applications identified in the appended Schedule (the "Inventions").
- (B) The Assignor contributed work towards the Inventions whilst an employee of the Assignee.
- (D) RAFT Enterprises Limited ("REL") is a company incorporated in the United Kingdom whose registered office is Leopold Muller Building, Mount Vernon Hospital, Northwood, Middlesex, HA6 2RN. The Assignee and REL executed an Assignment dated 29 March 2013, to assign rights in and to the Inventions to REL.
- (E) Smart Matrix Intellectual Property Limited ("SMIPL") is a company incorporated in the United Kingdom whose registered office is Leopold Muller Building, Mount Vernon Hospital, Northwood, Middlesex, HA6 2RN. REL and SMIPL executed an Assignment dated 29 October 2014, to assign rights in and to the Inventions to SMIPL.
- (F) By way of this confirmatory assignment, the Assignor confirms assignment of any and all of their rights in and to the Inventions to the Assignee, in the understanding of the Assignor and the Assignee that all rights in and to the Inventions ultimately reside with SMIPL by virtue of the Assignment from the Assignee to REL dated 29 March 2013, and the Assignment from REL to SMIPL dated 29 October 2014.

Now this Assignment witnesseth as follows:


### 1. Assignment

- 1.1 In consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee any and all of their rights, title and interest in and to the Inventions


together with the rights, privileges and advantages appertaining thereto including but not limited to the right to apply for, prosecute and obtain patent or similar protection throughout the world including the right to claim priority to the intent that the grant of any patents or similar protection shall be in the name of and vest in the Assignee.

- 1.2 The Assignee hereby accepts such assignment
- 1.3 The Assignor shall, at the expense of the Assignee, execute any further documents that may reasonably be required by the Assignee to enable the Assignee to enjoy the full benefit of the property and rights hereby assigned.
- 2. **Governing Law and Jurisdiction**
  - 2.1 The Agreement shall be governed by and construed in accordance with English law.
  - 2.2 Each of the parties irrevocably submits for all purposes in connection with this Agreement to the exclusive jurisdiction of the courts of England.
