~~Intended acquisition in kind: in accordance with the Federal Council decisions of 12 November 1997 and in 1st quarter 1998, applying Article 21 of the Telecommunications Enterprise Law as of 1 January 1998, the company intends to take over, without compensation, from the Swiss Confederation (PTT undertakings) agreements on line construction rights and rights of use, registered in the land register or not registered in the land register, as well as further obligatory agreements and limited rem rights, which serve the remote signalling technical transmission of data of the Swisscom AG or respectively of the companies connected thereto in the field of fixed network communication.~~
