ASSIGNATION (ASSIGNMENT) AGREEMENT

THIS AGREEMENT is made and entered into **BETWEEN:**

- (1) ENIGMA OILFIELD PRODUCTS LIMITED, incorporated and registered in Scotland with company number SC 386241 whose registered office is at 10 Baillieswells Drive, Bieldside, Aberdeen AB15 9AS (Assignor); and
- (2) MULTILIFT WELLBORE TECHNOLOGY LIMITED, incorporated and registered in Scotland with company number SC 390270 whose registered office is at 15 Golden Square, Aberdeen AB10 1WF (Assignee).

WHEREAS :-

- (A) ENIGMA OILFIELD PRODUCTS LIMITED is the named applicant in UK patent application number GB1021588.7 filed on 21 December 2010 and the patent applications identified in the attached Schedule (hereinafter referred to as "the Patents").
- (B) ENIGMA OILFIELD PRODUCTS LIMITED has agreed to assign all its rights in the invention described in UK patent application number GB1021588.7 (hereinafter referred to as "the Invention") and the Patents to MULTILIFT WELLBORE TECHNOLOGY LIMITED, and the parties wish to record the agreement in writing.

NOW THIS AGREEMENT WITNESSES as follows:-

1. In consideration of the sum of ONE POUND STERLING, the receipt and adequacy of which is hereby confirmed, ENIGMA OILFIELD PRODUCTS LIMITED hereby assigns and vests in MULTILIFT WELLBORE TECHNOLOGY LIMITED the whole of its rights in the Invention throughout the world, including the right to apply or to enable others to apply for and obtain a patent or patents or any other form of protection in respect of the invention described therein, including the right to claim priority, and the right to file divisional, substitution, replacement, continuation, reissue or extension patent applications for the Invention.
2. ENIGMA OILFIELD PRODUCTS LIMITED hereby undertakes to MULTILIFT WELLBORE TECHNOLOGY LIMITED that it will at the expense of MULTILIFT WELLBORE TECHNOLOGY LIMITED execute all documents and do all such acts and things as to MULTILIFT WELLBORE TECHNOLOGY LIMITED may in its absolute discretion consider necessary or desirable to enable Letters Patent or any form of protection to be issued in respect of the Invention in any part or parts of the world and to vest the same in the name of MULTILIFT WELLBORE TECHNOLOGY LIMITED or its nominee free from all encumbrances and to enable or to assist to MULTILIFT WELLBORE TECHNOLOGY LIMITED or its nominee to defend oppositions to grant thereof, to maintain the same when granted and to present and prosecute for the infringement thereof.


