WHEREAS I, **YIZHI CHEN**, residing at Guangzhou, China, have invented certain new and useful improvements in a

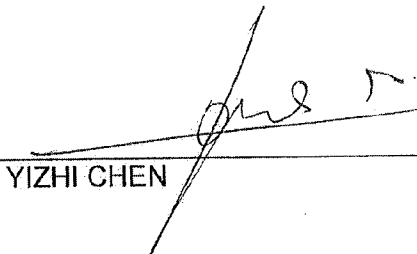
SLIM PEDAL BIN

for which an application for Letters Patent of the United States of America is being filed;

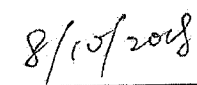
