RELEASE OF PATENT SECURITY AGREEMENT

THIS RELEASE OF PATENT SECURITY AGREEMENT ("Release"), dated as of September 25, 2018, is made by FIFTH THIRD BANK, an Ohio banking corporation, as Agent for the benefit of the Secured Creditors ("Agent"), and is as follows:

WHEREAS, Agent desires to release its rights and security interests in the Patent Collateral, including each mark, registration, and application listed on <u>Schedule I</u> attached hereto and each of the other Patent Rights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates its security interest in, Liens on, and all other rights in, to and under the Patent Collateral, including each mark, registration, and application listed on <u>Schedule I</u> attached hereto and each of the other Patent Rights.
