And ASSIGNOR further covenants and agrees that it will communicate to ASSIGNEE, its successors, assigns or other legal representatives, any facts known to it respecting the Patent Rights, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE, its successors, assigns or other legal representatives to obtain and enforce proper patent protection for said Patent Rights.

And ASSIGNOR hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.
