PATENT SECURITY AGREEMENT RELEASE

THIS PATENT SECURITY AGREEMENT RELEASE is made as of October 10, 2018, by **Wells Fargo Capital Finance, LLC**, a Delaware limited liability company and successor to Wells Fargo Foothill, LLC, as administrative agent ("Agent").

WITNESSETH:

WHEREAS, Agent and **Servigistics, Inc.**, a Delaware corporation ("Borrower"), are parties to that certain Patent Security Agreement ("Patent Security Agreement") dated as of September 30, 2009, pursuant to which Borrower granted a security interest to Agent in, among other things, the Released Patents (as such term is defined below) as security for certain obligations owing by Borrower; and

1. Agent hereby releases its security interest in all of Borrower's right, title and interest in and to the Patent Collateral (as defined in the Patent Security Agreement), including the patents listed on Schedule A attached hereto (the "Released Patents").

2. Agent hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Released Patents, and the goodwill of Borrower's business connected with the use of and symbolized by the Released Patents.

3. Agent authorizes Borrower to record this release with the U.S. Patent and Trademark Office and other applicable registry at the sole expense of Borrower. Borrower agrees to pay and shall pay all fees due to the U.S. Patent and Trademark Office associated with the filing and recordation of this Release.
