**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN PATENTS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS (the “Release”) is executed as of June 1, 2018, by DEUTSCHE TELEKOM AG, as administrative agent and collateral agent (together with its successors in capacity, the “Administrative Agent”) for the Secured Parties (as defined in the Credit Agreement referred to below) in favor of T-Mobile USA, Inc. (the “Grantor”). Unless otherwise indicated, capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement or Collateral Agreement as referred to below.

WHEREAS, reference is made to (a) that certain Secured Revolving Credit Agreement dated as of December 29, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the “Credit Agreement”), among the Grantor, the Lenders party thereto and the Administrative Agent and (b) that certain Collateral Agreement dated as of December 29, 2016 (as amended, supplemented or otherwise modified from time to time, the “Collateral Agreement”), with the grantors from time to time party thereto and the Collateral Agent;

WHEREAS, the Grantor and the Administrative Agent executed a certain Intellectual Property Security Agreement dated as of December 29, 2016 (as amended, supplemented or otherwise modified from time to time, the “IP Security Agreement”) pursuant to which the Grantor granted to the Administrative Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under the Patent Collateral (as defined therein) (the “Security Interest”), including the Patent listed on Exhibit A hereto, in order to induce the Lenders to make additional Loans and as consideration for Loans previously made;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on December 30, 2016 at Reel 041225 and Frame 0910; and

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest solely with respect to the Patent listed on Exhibit A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Administrative Agent hereby releases, terminates and discharges the Security Interest granted under the IP Security Agreement solely with respect to the Patent listed on Exhibit A hereto, and any right, title or interest of the Administrative Agent in such Security Interest shall hereby terminate, cease and become void. This Release does not release, relinquish, discharge or terminate the Administrative Agent’s security interest in any Intellectual Property or any other asset of the Grantor other than the Patent set forth in Exhibit A hereto. The Administrative Agent hereby consents to the recording of this Release with the USPTO and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest solely with respect to the Patent listed on Exhibit A as contemplated hereby.
