Assignment of Invention

WHEREAS, I, **Mark A. Kisner**, Sugar Land, Texas, United States of America and I, **Travis R. Kisner**, Houston, Texas, United States of America, have invented certain new and useful improvements in “**CHEMICAL SEQUENCING AND CONTROL TO EXPAND DETECTION CAPABILITIES UTILIZING A COLORIMETRIC TEST**” for which a provisional application was filed on November 20, 2012 under Serial Number 61/728,519, and in “**CHEMICAL SEQUENCING AND CONTROL TO EXPAND AND ENHANCE DETECTION CAPABILITIES UTILIZING A COLORIMETRIC TEST**” for which a PCT application was filed on March 15, 2013 under Serial Number PCT/US2013/032603 and for which a non-provisional application was filed on May 20, 2015, under Serial Number 14/646,105;


successors and assigns, to the full end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held by me had this Assignment and sale not been made.
