## PATENT RELEASE, TERMINATION AND REASSIGNMENT

THIS PATENT RELEASE, TERMINATION AND REASSIGNMENT is made as of October 24, 2018, by ANTARES CAPITAL LP, as collateral agent (“**Collateral Agent**”) in favor of W-Technology, Inc., a Texas corporation (the “**Grantor**”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

### WITNESSETH:

WHEREAS, Grantor and Collateral Agent were parties to that certain Patent Security Agreement dated as of August 16, 2018 (the “**Security Agreement**”) pursuant to which the Grantor granted a security interest to Collateral Agent in certain Patents and IP Collateral as security for certain obligations owing by Grantor to Collateral Agent, including the Patents set forth on **Schedule 1** hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on August 17, 2018, at Reel 046848, Frame 0762;

WHEREAS, Grantor has requested that Collateral Agent release its security interest in the Patents and IP Collateral and reassign any and all rights in the same to the Grantor; and

WHEREAS, the Collateral Agent acknowledges that the conditions for termination of its security interest in the IP Collateral have been met, and accordingly, the Collateral Agent has agreed to execute this Patent Release, Termination and Reassignment.


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby terminates, cancels, releases and discharges in its entirety its security interest in and to the IP Collateral. Collateral Agent hereby terminates the Security Agreement.
2. Collateral Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent’s right, title and interest in and to the Patents and the IP Collateral.
3. Collateral Agent agrees, at Grantor’s expense, to cooperate with the Grantor, to take all further actions and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the purpose of this Patent Release, Termination and Reassignment. Collateral Agent hereby authorizes and requests that the Commissioner for Patents of the United States Patent and Trademark Office record this Patent Release, Termination and Reassignment. This Patent Release, Termination and Reassignment shall be governed by, and construed in accordance with, the laws of the State of New York.
