ASSIGNMENT

Further, Biketronics assigns to Assignee the following additional rights:

- (b) the right to prosecute any such re-issue and re-examination applications;
- (c) the right to maintain such Patents;
- (d) the right to seek patent term extensions and patent term adjustments for such Patents;
- (e) the right to any allowable claims presented in, and of, such re-issue and re-examination applications;
- (f) all patent infringement claims (whether known or unknown or whether currently pending, filed or otherwise) arising from the infringement of any claim of the Patents, i.e. all causes of action and other enforcement rights, including the right to pursue, receive and collect any and all (1) past damages, (2) reasonable royalties, (3) lost profits, (4) injunctive relief, and (5) any other remedies of any kind for past, current, and future infringement, including enhanced damages and attorneys fees, e.g., for willful infringement; and
- (g) all rights to collect royalties, license fees, and all other forms of payment on account of the Patents.

Assignor hereby authorizes the United States Patent and Trademark Office to issue any and all patents, including any re-examination and re-issue patents, that may be granted upon said Patents in the name of Assignee, as assignee to the entire right, title, and interest therein.

The terms and conditions of this Assignment will inure to the benefit of Assignee, its successors, assigns and other legal representative and will be binding upon Assignor, its successors, assigns, and other legal representatives.
