**RELEASE OF SECOND LIEN SECURITY INTEREST IN CERTAIN PATENTS**

This **RELEASE OF SECOND LIEN SECURITY INTEREST IN CERTAIN PATENTS**, dated as of August 22, 2018 (this "Release"), is made by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH**, as the Collateral Agent (in such capacity, together with its successors and permitted assigns, herein called the "**Collateral Agent**") for the Secured Parties, in favor of **QUEST SOFTWARE INC.** (the "Grantor"). Capitalized terms used in this Release and not otherwise defined herein have the meanings given to them (including by reference) in the Security Agreement (as defined below).

**WHEREAS**, the Grantor and the Collateral Agent are parties to that certain (i) Second Lien Security Agreement, dated as of May 18, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and (ii) Second Lien Patent Security Agreement dated as of May 18, 2018 (the "Patent Security Agreement"), pursuant to which the Grantor granted to Collateral Agent (for the benefit of the Secured Parties) a security interest in all of Grantor's right, title and interest in and to the Patent Collateral (as defined in the Patent Security Agreement);

**WHEREAS**, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on June 7, 2018 at Reel/Frame 046327/0486;

**WHEREAS**, the Grantor has informed the Collateral Agent that all right, title and interest in and to the (i) the patents and patent applications set forth on Schedule A annexed hereto, all re-issues, divisions, continuations, renewals, extensions and continuations in-part thereof and all rights corresponding thereto; (ii) the right to sue or otherwise recover for any past, present and future infringement, or other violation or impairment of any of the foregoing; and (iii) all Proceeds of the foregoing, including all license fees, royalties, income, payments, claims, damages and proceeds of suit, now or hereafter due and/or payable with respect to any of the foregoing (collectively, "Released Patent Collateral") were assigned to Sonicwall US Holdings Inc. and that the Released Patent Collateral was erroneously described as part of the Patent Collateral; and


**WHEREAS**, because the Grantor incorrectly granted to the Collateral Agent and recorded with the United States Patent and Trademark Office a security interest in the Released Patent Collateral, the Collateral Agent has agreed to execute and deliver this Release.

**NOW THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without any representation, warranty or recourse of any kind or nature, hereby terminates, cancels and releases its security interest in the Released Patent Collateral, including the patents and patent applications set forth on Schedule A attached hereto, and hereby re-assigns, re-transfers and re-conveys to the Grantor any and all right, title and interest the Collateral Agent may have in or to the Released Patent Collateral, including the patents and patent applications set forth on Schedule A attached hereto.
