ASSIGNMENT

WHEREAS, WE, Mohamed Nabil NOUI-MEHIDI, a citizen of Australia and Ilies MOSTEFAL, a citizen of Algeria, are the sole inventors of a **METHOD AND APPARATUS FOR SUB-TERRAIN CHLORINE ION DETECTION IN THE NEAR WELLBORE REGION IN AN OPEN-HOLE WELL**, for which a non-provisional application for United States Letters Patent is herewith filed; and

And we hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said invention or resulting from said application and from any and all divisions, continuations, and reissues thereof, to SAUDI ARAMCO, as assignee of our entire interest, and hereby covenant that we have the full right to

convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.



And we do further covenant and agree that we will, at any time upon request, communicate to SAUDI ARAMCO, its successors, assigns or other legal representatives, such facts relating to said invention and Letters Patent or the file history thereof as may be known to us, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.
