Form of U.S. Patent Assignment

PATENT ASSIGNMENT

This Patent Assignment ("Assignment") is entered into as of June 30, 2015 ("Effective Date") by and between Yahoo! Inc., a Delaware corporation, having an address at 701 First Avenue, Sunnyvale, CA 94089 ("Yahoo") and Snapchat, Inc., a Delaware corporation, having an address at 63 Market Street, Venice, CA 90291 ("Snapchat").

WHEREAS, Yahoo and Snapchat have entered into that certain Patent Sale, Assignment and Cross-License Agreement, dated as of June 30, 2015 (the "Patent Sale, Assignment and Cross-License Agreement"), pursuant to which Yahoo has agreed, among other things, to sell and transfer to Snapchat the patents and patent applications listed in Exhibit 1 of this Assignment;

WHEREAS, Yahoo owns all right, title and interest in and to such patents and patent applications; and

WHEREAS, Yahoo desires to assign to Snapchat, and Snapchat desires to receive, all of Yahoo's right, title and interest in and to such patents and patent applications.

NOW, THEREFORE, pursuant to the Patent Sale, Assignment and Cross-License Agreement, and for good and valuable consideration given and received, the receipt and legal sufficiency of which is hereby acknowledged, Yahoo and Snapchat, intending to be legally bound hereby, agree as follows:

- (A) Yahoo hereby irrevocably transfers, conveys, assigns and delivers to Snapchat, and Snapchat hereby accepts:
- (1) all of Yahoo's right, title and interest throughout the world (including, without limitation, all rights provided by international conventions and treaties) in and to:
 - (a) all patents and patent applications listed in Exhibit 1 and any patents granted on any of the patent applications listed in Exhibit 1; and
 - (b) any patents or patent applications that claim priority to any of the items in (a) (including, without limitation, any continuations, divisions, substitutes, reissues, reexaminations, extensions and renewals thereof) (all of the foregoing in (a) and (b), collectively, the "Assigned Patents");
 - (2) all rights to causes of action and remedies with respect to the Assigned Patents, including, without limitation, the right to sue (including, without limitation, for damages and injunctive relief) for any past, present or future infringement, violation, dilution or other unauthorized use of any of the Assigned Patents;
 - (3) all rights to receive income, royalties, damages, payments or other consideration with respect to the Assigned Patents;
 - (4) all rights to prosecute and maintain the Assigned Patents; and

- (5) all other rights and interests arising out of or with respect to the Assigned Patents.
- (B) This Assignment will be governed by and construed in accordance with the laws of the State of California and the federal laws of the United States (without application of any choice or conflict of laws rules or principles that would require the application of the laws of any other jurisdiction). Each party hereto (a) hereby irrevocably submits itself to and consents to the jurisdiction of the U.S. District Court for the Northern District of California (or if such court lacks jurisdiction, the state courts located in Santa Clara County, California) for the purposes of any action, claim, suit, proceeding, or dispute arising out of or relating to this Assignment, and (b) hereby waives, and agrees not to assert, by way of motion, as a defense or otherwise, in any such action, claim, suit or proceeding, any claim that it is not personally subject to the jurisdiction of such court(s), that the action, claim, suit or proceeding is brought in an inconvenient forum or that the venue of the action, claim, suit or proceeding is improper.
- (C) This Assignment may be executed in one or more counterparts (including by facsimile or electronic transmission), each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement.

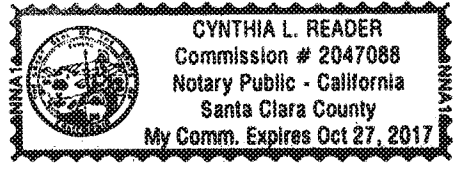


