embodiments of the Invention; (d) for filing and prosecuting applications for reissuance of any of the Patents; (e) for interference or other priority proceedings involving the Invention; and (f) for legal proceedings involving the Invention and any application therefor and any Patents granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the expense incurred by the Assignors in providing such cooperation shall be paid for by the Assignee.

3. The term and covenants of this agreement shall inure to the benefit of the Assignee, its successors, assigns and other legal representatives, and shall be binding upon the Assignors, their respective heirs, legal representatives and assigns.


