Assignor does hereby authorize the Director of the United States Patent & Trademark Office, and the empowered officials of all other governments whose duty it is to record patents, applications and title thereto, to record the Assigned Patents and title thereto as the property of Assignee, its successors, assigns, or legal representatives in accordance with the terms of this instrument.


