ASSIGNMENT

WHEREAS, I, Richard P. Martter, resident of Dallas, Dallas County, Texas and citizen of the United States, have invented certain new and useful improvements in:

- (i) "REINFORCING ASSEMBLIES HAVING DOWNWARDLY-EXTENDING WORKING MEMBERS ON STRUCTURALLY REINFORCING BARS FOR CONCRETE SLABS OR OTHER STRUCTURES" disclosed in an application for United States Letters Patent (U.S. Patent Application No. 15/646,331 filed on July 11, 2017, which is issuing as U.S. Patent No. 10,119,276 on November 6, 2018); and
 - (ii) "REINFORCING ASSEMBLIES HAVING DOWNWARDLY-EXTENDING WORKING MEMBERS ON STRUCTURALLY REINFORCING BARS FOR CONCRETE SLABS OR OTHER STRUCTURES" disclosed in an application for United States Letters Patent (U.S. Patent Application No. 16/152,830 filed on October 5, 2018);
- (hereinafter collectively referred to as "INVENTIONS" or "APPLICATIONS").

WHEREAS, ConBar Systems LLC, a limited liability company organized under the laws of the State of Texas, having a place of business at 12460 Montego Plaza, Dallas, Texas 75230 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring my entire right, title and interest in and to the INVENTIONS and in and to the APPLICATIONS and any Letters Patent that may issue thereon.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I do hereby sell, assign and transfer unto the ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive right, title and interest in and to the INVENTIONS and in and to the APPLICATIONS and all patents that may be granted therefor, and all divisions, reissues, substitutions, continuations, continuations-in-part and extensions thereof; and I hereby authorize and request the Commissioner of Patents to issue all patents for the INVENTIONS, or patents resulting therefrom, insofar as my interest is concerned, to the ASSIGNEE of my entire right, title and interest.

I also hereby sell and assign to the ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the INVENTIONS disclosed in the APPLICATIONS throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for the INVENTIONS in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of the INVENTIONS and all rights to register the INVENTIONS in appropriate registries; and I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

I hereby further agree that I will communicate to the ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to me respecting any improvements; and, at the expense of the ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and

generally do everything possible to vest title in the ASSIGNEE and to aid the ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for the INVENTIONS in all countries.
