I hereby authorize and request the Patent Office officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said NV Bekaert SA as the assignee of my entire right, title and interest in and to the same, for the sole use and behoof of said NV Bekaert SA, its successors and assigns.


Further, I agree that I will communicate to said NV Bekaert SA or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuations, substitutions, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said NV Bekaert SA, make all rightful oaths and generally to do everything possible to aid said NV Bekaert SA, its successors and assigns, to obtain and enforce protection for said invention in the United States and in any and all foreign countries.
