PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT is entered into by and between Main Attractions, LLC, (Main) a limited liability company organized under the laws of the State of Kansas, and Kingdom Trust Co., fbo the Steven J. Levine IRA (Levine).

WHEREAS, Main is entering into an Asset Purchase Agreement with Eco Adventure Technologies, LLC, a Texas LLC;

WHEREAS, as part of the Asset Purchase Agreement, Main will acquire Intellectual Property regarding the AvatarOne Roller Coaster Zip Line System:

WHEREAS, Main would like to sell and assign all its rights in the Intellectual Property to Levine;

NOW, THEREFORE, in consideration of the premises and good and valuable consideration of one hundred and thirteen thousand, nine hundred thirty-four dollars and seventy cents (\$113,934.70) the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Upon completion of its purchase of the terms of the Asset Purchase Agreement dated July 20, 2015, Main agrees to assign, grant, transfer, and otherwise conveys to Levine all of Main's interest in the intellectual property acquired in the Asset Purchase Agreement. This shall specifically include provisional patent application number 61/315,619 filed March 19, 2010. US8863668 and any and all other such patents under control of Eco Adventure Technologies, its members and affiliates that are part of or pertain to the AvatarOne Roller Coaster Zip Line System; and all trademarks, designs, drawings, engineering reports, installation manuals, maintenance manuals, marketing materials or other written work product used in the manufacture, engineering, installation, maintenance or sales of the AvatarOne product.

2. Levine hereby accepts the foregoing assignment, grant, transfer, and conveyance.
