"Simmondsin formulation" to Mr VAN DEN DRIESSCHE.


In agreement of said assignment, the entire right, title and interest of the said invention belong

national/regional phases to be possibly entered before November 4, 2018.


Mr RAES Stefaan agrees with the assignment of the rights belonging to Mr
