WHEREAS

3. In consideration of the sum of one pound sterling (£1) (receipt of which is hereby acknowledged by the Employer), the Employer hereby ASSIGNS to the Assignee with full title guarantee all of his right title and interest in and to the Patent Application and the Invention for all countries of the world, including without limitation the United Kingdom and all countries of the Patent Cooperation Treaty, including the right to file applications for and obtain corresponding protection in any and all countries of the world and to claim priority from the Application, together with any and all divisional, continuation, continuation-in-part, reissue applications and the like, and the Employer hereby CONSENTS to the filing of any and all applications in respect of said invention in the name of the Assignee.
4. The 1st, 2nd and 3rd Inventors hereby covenant and agree to do all such things and to execute without further consideration such documents as may be reasonably required to file and prosecute applications for protection of the Invention in such countries as shall be determined by the Assignee, and at the expense of the Assignee to give all reasonable assistance in obtaining and enforcing any such protection.
