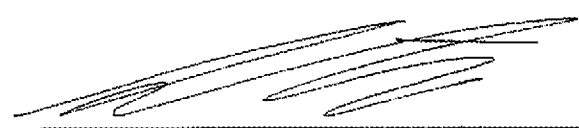

The undersigned, Andrew Butler, hereby certifies that:

1. He is the duly elected and acting President of Zugworks, Inc., a Delaware corporation.
2. The Certificate of Incorporation of this corporation was originally filed with the Secretary of State of Delaware on September 5, 2014.
3. Pursuant to Section 242 of the Delaware General Corporation Law, this Certificate of Amendment of the Second Amended and Restated Certificate of Incorporation amends Article I of this corporation's Second Amended and Restated Certificate of Incorporation to read in its entirety as follows:

"ARTICLE I
NAME OF CORPORATION

The name of the corporation is Square Panda Inc. (the "Corporation")."

4. Pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment of the Second Amended and Restated Certificate of Incorporation amends the first paragraph of Article IV of this corporation's Second Amended and Restated Certificate of Incorporation to read in its entirety as follows:

"ARTICLE IV
AUTHORIZED CAPITAL STOCK

The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 100,000,000 shares of Common Stock, \$0.0001 par value per share ("Common Stock") and (ii) 37,000,000 shares of Preferred Stock, \$0.01 par value per share ("Preferred Stock"), 20,000,000 of which are designated as Series A Preferred Stock (the "Series A Preferred Stock") and 17,000,000 of which are designated as Series B-1 Preferred Stock (the "Series B-1 Preferred Stock").

The foregoing Certificate of Amendment of Second Amended and Restated Certificate of Incorporation has been duly adopted by this corporation's Board of Directors and stockholders in accordance with the applicable provisions of Sections 141, 228 and 242 of the Delaware General Corporation Law.
