CONFIRMATORY ASSIGNMENT

WHEREAS IWE Alexander Charles WEYMOUTH-WILSON, Laura WALLIS, Timothy EVANS and Zofia KOMSTA, all British citizens, all c/o Dextra Laboratories Ltd, Science & Technology Centre, Earley Gate, Whiteknights Road, Reading, RG6 6BZ, United Kingdom; (hereinafter called the "**Inventors**") have invented or discovered "**METHODS AND COMPOUNDS**" (hereinafter called the "**Invention**") for which a PCT international application **PCT/GB2017/051389** was filed on **18 May 2017**, designating *inter alia* the United States of America and naming the aforesaid individuals as inventors, claiming priority to application **1608776.9**, filed on **18 May 2016**, at the UK Intellectual Property Office (hereinafter referred to as the "**Applications**");

WHEREAS Laura WALLIS, Timothy EVANS and Zofia KOMSTA were employed at the time of making of the **Invention** by NZP UK Limited, Science & Technology Centre, Earley Gate, Whiteknights Road, Reading, RG6 6BZ, United Kingdom (English company number 02420895, previous company name: Dextra Laboratories Limited) ("**NZP UK**") and whereas the **Invention** was made in the course of employment under circumstances whereby an invention may reasonably be expected to result, and all rights in and to the **Invention** were assigned to **NZP UK** by operation of law, specifically s39 of the Patents Act 1977, and moreover by virtue of a specific assignment clause in their contracts of employment;

WHEREAS Alexander Charles WEYMOUTH-WILSON was Director of **NZP UK** at the time of making the **Invention** and whereas the **Invention** was made in the course of his normal duties as a Director of **NZP UK** or in the course of duties falling outside his normal duties, but specifically assigned to him, and the circumstances were such that an invention might reasonably be expected to result from the carrying out of his duties, or that the **Invention** was made in the course of his duties and at the time of making the **Invention**, because of the nature of his duties and the particular responsibilities arising from the nature of his duties as a director he had a special obligation to further the interests of **NZP UK's** undertaking, and:

WHEREAS the **Inventors** and **NZP UK** have authorised and requested the filing of the **Applications**;

WHEREAS **NZP UK** is desirous of confirming its entitlements in and to the **Invention** and in and to the **Applications**;

NOW, THEREFORE, to all whom it may concern be it known that for consideration of the amounts set out in the aforementioned agreements and the sum of £1 (one pound sterling) the sufficiency of which is hereby acknowledged, we the **Inventors** hereby confirm the ownership by **NZP UK** of the **Invention** and the **Applications** and, if under the law of any territory (such as the United States of America) we have any ownership right, title and interest in and to the **Invention** and the **Applications**, (which we do not believe to be the case and claim no ownership right, title or interest in and to the **Invention** or the **Applications**), we nevertheless hereby assign and transfer to **NZP UK** all ownership right, title and interest in and to the **Invention** and the **Applications**, including the right to claim priority from the **Applications** in respect of any subsequent applications, and in and to any divisional application, continuation or continuation in part application thereof, and in and to any extension, or re-issue thereof, or Supplementary Protection Certificate based thereon, and we the **Inventors** hereby authorise and request any patent arising therefrom in any territory of the world be issued to **NZP UK**;

AND I/we the **Inventors** for ourselves and our respective executors and legal representatives hereby agree to provide information and to make, execute and deliver any and all other instruments in writing, and any and all further acts, applications, papers, affidavits, assignments and other documents which may be possible and are necessary or desirable to more effectually secure to and vest in **NZP UK**, its successors and assigns, the whole right, title and interest in and to the **Invention** and the **Application**.


