NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged by the Assignor to have been received in full:



The Assignor hereby covenants that it has full right to convey the entire interest herein assigned free from all prior assignments, agreements, licenses, mortgages and other encumbrances, and agrees to execute any and all documents reasonably required to effect this Assignment and in connection with divisional, continuing, reissue and other applications, and to take such other actions as reasonably requested by Assignee to obtain and enforce patent protection for the Patents.

3. The terms and covenants of this Assignment shall inure to the benefit of the Assignee, its successors and assigns and other legal representatives, and shall be binding upon the Assignor, his respective heirs, legal representatives and assigns.
