TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT COLLATERAL** (this “Release”) is made as of November 26, 2018 (“Effective Date”), by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as agent for each member of the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (together with its successors and assigns in such capacity, “Agent”), in favor of **OBJECTIVE SYSTEMS INTEGRATORS, INC.**, a Delaware corporation (“Grantor”).

WHEREAS, reference is made to that certain Credit Agreement, dated as of May 30, 2014 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among the lenders identified on the signature pages thereof, Agent, **MYSOFT HOLDINGS USA, INC.**, a Delaware corporation (“Parent”), Grantor, and the other Borrowers (as defined therein) from time to time party thereto (including Grantor);

WHEREAS, pursuant to the terms and conditions of that certain Patent Security Agreement, dated as of May 30, 2014, by and among Grantor and Agent, which was recorded with the United States Patent and Trademark Office on May 30, 2014, at Reel 033072, Frame 0142, (as amended, restated, supplemented, or otherwise modified and in effect from time to time, the “Patent Security Agreement”), Grantor granted to Agent a security interest in all of Grantor’s right, title, and interest in and to the Patent Collateral (as such term is defined in the Patent Security Agreement); and

WHEREAS, Agent now desires to release its security interest in the Patent Collateral, including, without limitation, the patent registrations and applications listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Agent hereby terminates, releases, and discharges its security interest in the Patent Collateral granted pursuant to the Patent Security Agreement, and reassigns to Grantor all right, title, and interest of Agent in the Patent Collateral pursuant to the Patent Security Agreement.


2. Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts, in each case at the Borrowers’ expense, as may be reasonably necessary to effect the release of the security interest in the Patent Collateral contemplated hereby.
