3. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to

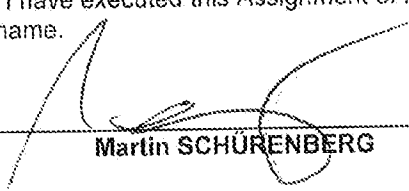

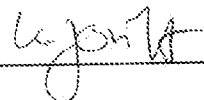
