THIS CONFIRMATORY ASSIGNMENT (this "Assignment") is made and entered into this 14th day of NOVEMBER 2018, but to be effective as of 18 December 2017 (the "Effective Date")

BETWEEN:

- (1) **Avocet Infinite plc**, a company incorporated in the United Kingdom under Company No. 09346715, with its registered office at 25 Palace Street, Berwick-Upon-Tweed, Northumberland, United Kingdom, TD15 1HN (the "Assignor"); and
- (2) **Avocet IP Limited**, a company incorporated in the United Kingdom under Company No. 11112409, with its registered office at 25 Palace Street, Berwick-Upon-Tweed, Northumberland, United Kingdom, TD15 1HN (the "Assignee").

Together, the "Parties".

RECITALS

WHEREAS:

- (A) Pursuant to an oral agreement entered into on 18 December 2017 between the Parties (the "Oral Agreement"), the Assignor assigned all its rights, title, interest and benefit in respect of the Intellectual Property Rights (as defined below) to the Assignee.
- (B) The Assignor hereby provides confirmation of that assignment.

IT IS AGREED AS FOLLOWS:

1. DEFINITIONS AND INTERPRETATION

- 1.1 The definitions in this Clause shall apply to this Assignment (including the Recitals above):

"Further Patent Applications": all PCT applications (including national stages thereof), regional patent applications and domestic patent applications, including continuations, divisionals, continuations-in-part, and patents issuing therefrom, including reissues, re-examinations, extensions (such as patent term extensions), certificates of invention, and the like that derive priority from, or claim the benefit of the filing date of, the Patent Applications, as well as any other patent applications of which the Assignor is the proprietor, including but not limited to the patent applications, short particulars of which are set out in Schedule 1.

"Granted Patents": the rights, title, interest and benefit in the granted patents, short particulars of which are set out in Schedule 2B.

"Inventions": all new inventions and improvements that are disclosed in the Patent Applications, together with all inventions in development or under consideration by the Assignor which have yet to be filed as patent applications.

"Intellectual Property Rights": the Patent Assets; the Trade Marks, service marks, domain names, business names, get up, logos, goodwill, designs, symbols, emblems,

insignia and slogans; copyright and related rights; database rights; know-how and trade secrets; and all other intellectual and industrial property rights which subsist or will subsist now or in the future in any part of the world, whether registered or not or capable of registration or not, including: all applications for and the right to apply for, claim priority and be granted any such rights; any renewals, extensions or restorations, and divisional, continuation and reissued applications of any such rights.

"Patent Applications": the rights, title, interest and benefit in the patent applications, short particulars of which are set out in Schedule 2A.

"Patent Assets": the Inventions, the Granted Patents, the Patent Applications and the Further Patent Applications.

"Trade Marks": the registered trade marks and the trade mark applications, short particulars of which are set out in Schedule 3, and any unregistered trade marks and trade names.

2. CONFIRMATION OF ASSIGNMENT


2.1 The Assignor hereby confirms that it assigned, transferred and conveyed the Intellectual Property Rights to the Assignee pursuant to the Oral Agreement, and to the extent not already assigned, hereby assigns, transfers and conveys to the Assignee, absolutely the entire worldwide rights, title, interest and benefit in and to the Intellectual Property Rights (whether such rights, title, interest and benefit are owned individually or jointly), including:

- (a) the right to file and prosecute patent applications, including corresponding continuations, divisionals, continuations-in-part, and patents issuing therefrom, including reissues, re-examinations, extensions (such as patent term extensions), certificates of invention, and the like based on any of the Further Patent Applications, Inventions or Patent Applications;
- (b) the right to claim priority from any of the Patent Applications and Trade Marks pursuant to the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, The Protocol Relating to the Madrid Agreement Concerning the International Registration of Marks and all other treaties or legislation of like purposes;
- (c) the absolute entitlement to any registrations granted pursuant to any of the applications which form part of the Patent Assets and Trade Marks;
- (d) all goodwill attaching to the Trade Marks and in respect of the business relating to the goods or services for which the Trade Marks are registered or used; and
- (e) the right to bring, make, oppose, defend and appeal proceedings, claims, actions or demands, whether known or unknown, suspected or unsuspected, of any nature, including choses in action, and to obtain profits, costs (including attorneys' fees), monetary awards, restitution, relief (and to retain any damages recovered, including any statutory, enhanced or punitive damages) in respect of any misuse or infringement, including past infringements, or any other cause of action arising from ownership of any Intellectual Property Rights, whether occurring before, on, or after the date of this Assignment.

This Assignment has been executed as a deed and is delivered to take effect on the Effective Date.






