- (2) The Assignee shall by virtue of the Assignment be entitled to the grant of any resulting patents.
- (3) The Assignor hereby covenants with the Assignee that the Assignor will at the expense of the Assignee execute sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned and (if requested to do so by the Assignee) to apply for any patents or other forms of protection in respect of the UK Patent, the PCT Application or the Inventions to vest the same in the Assignee or as the Assignee shall direct.
- (4) This Assignment shall be governed by English law and shall be deemed to have been made in England. Save as provided for by any mutual agreement of the parties to arbitrate, the Courts of England shall have exclusive jurisdiction to entertain any dispute relating to a point of law or fact.


