#### ASSIGNMENT OF PATENT RIGHTS

- (d) rights to collect past and future royalties or other payments for a license under or on account of the Patent and/or any of the foregoing, other than as agreed upon by the parties.

Assignor hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models or other governmental grants or issuances that may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.


