NOW, THEREFORE, to all whom it may concern be it known that for and in consideration of said agreements and of other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNORS have sold, assigned and transferred and by these presents do hereby sell, assign and transfer unto said ASSIGNEE, its successors, assigns and legal representatives, the entire right, title and interest in and throughout the United States of America, its territories and all foreign countries, in and to said invention as described in said application and all divisionals, renewals, and continuations thereof, together with the entire right, title and interest in and to said application and such Letters Patent as may issue thereon and all reissues and extensions thereof; said invention, application and Letters Patent to be held and enjoyed by said ASSIGNEE for its own use and behalf and for its successors, assigns and legal representatives, to the full end of the term for which said Letters Patent may be granted as fully and entirely as the same would have been held by us had this assignment and sale not been made; ASSIGNORS hereby convey all rights arising under or pursuant to any and all international agreements, treaties or laws relating to the protection of industrial property including, without limitation, all applications for patents, utility models and designs which may be filed for said invention in any countries foreign to the United States together with the right to file such applications and the right to claim for the same the priority rights claimed in or derived from said application or any priority application thereof under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed as may be applicable; and all forms of industrial property protection including, without limitation, patents, utility models, inventor's certificates, and designs which may be granted for said invention in any country foreign to the United States and all extensions, renewals and reissues thereof; and all right to sue for infringement including past infringement. ASSIGNORS hereby acknowledge that this assignment, being of the entire right, title and interest in and to said invention, carries with it the right in ASSIGNEE to apply for and obtain from competent authorities in all countries of the world any and all Letters Patent by attorneys and agents of ASSIGNEE's selection and the right to procure the grant of all such Letters Patent to ASSIGNEE for its own name as assignee of the entire right, title and interest therein;

AND, ASSIGNORS, together with the ASSIGNEE, do hereby authorize and request the Commissioner of Patents of the United States to issue such Letters Patent as shall be granted upon said application or applications based thereon to said ASSIGNEE, its successors, assigns, and legal representatives.


