Article FIRST of the Certificate of Incorporation is deleted in its entirety and replaced with the following:

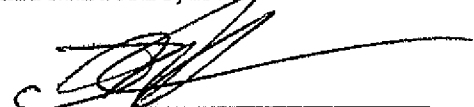
"The name of the corporation is Alpha Assembly Solutions Inc. (the "Corporation")."
